It is simple and quick to transfer securities, and there are tax benefits. You can also give a gift of securities in your will to support your parish endowment fund, which makes a lasting difference. **Gifts to the Parish Using Your Retirement Plan:** All 401Ks and retirement plans have beneficiaries. Leaving these plans to children can result in a large percentage going to taxes. Please consider naming the parish endowment fund as a beneficiary of your retirement plan – even if just a percentage.
