



Bulletin notes for November 2020

As we approach the end of the year, we are focusing on a type of fund that benefits your older parishioners as well as the parish endowment fund. In November, the focus is on Charitable Gift Annuities.

Week 1: November 1

Increase your retirement income, receive a tax deduction and leave a gift to the parish. If you are 65 or older, you can create a charitable gift annuity and receive quarterly payments for life. Current sample rates: **65 – 4.2%; 70 – 4.7%; 75 – 5.4%; 80 – 6.5%, 85 – 7.6%**. Week 2: November 8

Receive income and help our parish: If you are 65 or older, would like additional income, a tax deduction and make a gift to the parish endowment fund, consider a Charitable Gift Annuity. Current sample rates: **65 – 4.2%; 70 – 4.7%; 75 – 5.4%; 80 – 6.5%, 85 – 7.6%**. Week 3: November 15

A forever gift with income today: If you are 65 or older, you can make a gift of cash or stock and receive an immediate tax savings. In return, the Foundation makes regular fixed payments to you. Current sample rates: **65 – 4.2%; 70 – 4.7%; 75 – 5.4%; 80 – 6.5%, 85 – 7.6%**. Upon your death, the remaining balance is given to the parish endowment fund. Consistent income stream and support for the parish: A charitable gift annuity is a fund that provides you with fixed, guaranteed payments for life. At your death, the remainder is given to the parish endowment fund allowing your generosity to continue forever. Current sample rates: **65 – 4.2%; 70 – 4.7%; 75 – 5.4%; 80 – 6.5%, 85 – 7.6%**. Want to get a better interest rate on your savings? A charitable gift annuity provides higher interest rates, based on age, that can also benefit your parish endowment.
