The bulletin notes for March focus on making a gift of an IRA rollover to the parish endowment fund for those who are 70 ½ or over. An IRA rollover can benefit your parishioners as well as the parish, as they can save on taxes when they make the gift to the parish.

### **March 7 – Third Sunday of Lent**

**Lower Your Income and Taxes with an IRA Rollover Gift to the Parish:** With an IRA rollover gift to the parish endowment fund, you can support your parish without impacting cash flow – and benefit from lowering income and taxes. If you are 70½ or older, you can make an IRA rollover gift and help support the parish long into the future. ### **March 14 – Fourth Sunday of Lent**

**Save on Taxes with a Gift of an IRA to the Parish:** The IRA Charitable Rollover is permanent for those 70½ or older. You can make a gift directly from your IRA account to your parish endowment fund and benefit from lowering your income and taxes.
