Benefit Your Parish with a Gift of an IRA: A simple way to give a gift to your parish is with an IRA qualified charitable distribution. If you are over 70 ½, you can make a direct transfer from your IRA to the parish endowment fund, and this would not be taxed or counted as taxable income.
