If you are over 65, would like to receive additional income, need a tax deduction, and would like to make a lasting gift to your parish, a Charitable Gift Annuity may the answer. Rates are increasing as of July 1, 2018 – which is good news! Your rate of return is based on your age. For example, if you are 70, you would receive 5.6%; if you are 80, you would receive 7.3%; and if you are 90 or older, you would receive 9.5%.
