## Stay in your home and receive a Charitable Tax Deduction

A Life Estate Reserved may be the plan for you. With this plan, you deed your home to the Catholic Foundation of North Georgia to benefit your parish endowment fund, and you reserve the right to continue using it for life. You receive the tax deduction now, but will be responsible for the upkeep of the home.
