

Registration is now open for #iGiveCatholic 2018!

The first step to participate in the giving day is to register! Your organization's designated point person should have received an email link from GiveGab, the #iGiveCatholic website partner, to activate your profile page. The point person can add other administrators to your team once your profile is activated.

Why is GiveGab asking for my social security number in order to register?

Because GiveGab is an online platform that collects, processes and distributes money in the form of donations from supporters to organizations, they fall under certain regulations for US based organizations, and are required to abide by compliance laws that are part of the Patriot Act.

In short, they need to verify that the individual who is signing up an organization to collect donations is who they say they are and is authorized to do so. They also need to verify that the organization is a legitimately registered corporation.

Collecting this information helps them streamline donation processing and payouts with their underlying payment processor (Stripe) and the financial institutions they work with.

According to GiveGab, "More importantly, we have a duty to our users that when they choose to support a cause with a monetary gift, that money is going where they expect it to go! GiveGab takes the highest security measures to ensure your information is protected. We've partnered with Stripe as our payment processor and underwriter for nonprofit verification, which is a PCI Service Provider Level 1- the most stringent level of certification possible."
